The goods and services shown below are those we can provide for our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

PROFESSIONAL SERVICES

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF AND OVERHEAD **\$2,995.00**

This fee for our basic **services and overhead** will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Our services include: conducting the arrangements conference with family or responsible party; ordinary sheltering of remains; arrangement of funeral, graveside, memorial service or other ceremony; preparation of the death certificate, necessary authorizations and permit; preparation and placement of obituary notices; staff assistance prior to the ceremony, including coordination with those providing other portions of the service, i.e. cemetery, crematory, clergy and/or any other necessary parties. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment.

EMBALMING **\$995.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Limited to 10 people for up to 30 minutes.

Our services include coordinating the funeral arrangements, set-up and supervision of the funeral, arranging floral displays, and staff and equipment to conduct the funeral ceremony. If the ceremony is held in our chapel, the use of these facilities will be included.

Our services include coordinating the funeral arrangements, set-up and supervision of the funeral, arranging floral displays, and staff and equipment to conduct the funeral ceremony.

Our services include coordinating the memorial service arrangements, set-up and supervision of the memorial service, arranging floral displays, and staff and equipment to conduct the memorial service. If the memorial service is held in our chapel, the use of the facilities will be included.

TRANSPORTATION

All transportation charges contained within this list apply to a service radius of 30-miles. If we exceed this service area, in addition to the basic vehicle charge, which covers 30 of the total miles traveled from our facility, we will make an additional charge of \$4.50 per loaded mile for a staffed vehicle. If an overnight stay is required due to the round-trip exceeding 400 miles or, due to no fault of ours, our driver and vehicle cannot safely return the same day, there will be an additional charge of \$350.00 (for overtime, hotel, and meal expenses).

MINIMAL SERVICES

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME **\$1,695.00**

Our charge includes basic services of the funeral director and staff; a proportionate share of overhead costs; transportation of the remains from the Reno Tahoe International Airport or other local debarkation point to the funeral home, cemetery or crematory; **NOTE:** additional transportation fees will apply if from another airport or debarkation point. **NOTE:** This service **does not** include staff, facilities or equipment for viewing/visitation, funeral ceremony or committal service and **does not** include merchandise or cash advances made by us on your behalf.

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME **\$2,195.00**

Our charge includes: basic services of the funeral director and staff; a proportionate share of overhead costs; transportation of the remains from the place of death to the funeral home (within a 30-mile radius); embalming; transportation of the deceased to Reno Tahoe International airport or other local embarkation point; **NOTE:** additional transportation fees will apply if to another airport or embarkation point; **NOTE:** Other items required may be a Combination Shipping Container or Air Tray. Airlines require the use of an approved Combination Shipping Container or the use of a Casket and Air Tray. If any other services are requested and provided, such as, other preparation of the deceased; bathing, dressing, casketing, cosmetology and hair styling (if necessary); or viewing and visitation, additional charges will apply. This service **does not** include merchandise or cash advances made by us on your behalf.

IMMEDIATE BURIAL

IMMEDIATE BURIAL WITH NO VIEWING – NO CEREMONY **\$2,995.00 - \$32,990.00**

Our charge for an immediate burial (without ceremony) includes basic services of funeral director and staff; a proportionate share of overhead costs; transfer of the deceased from the place of death to the funeral home (within a 30-mile radius); preparation of death certificate and permit; and local transportation to the cemetery. Immediate burial is the process of arranging for the burial or an unembalmed body as soon as possible after death. If difficulties in filing a death certificate and/or securing the necessary legal permit immediately and/or the cemetery's inability to open a grave on short notice delay the immediate burial longer than 24 hours after death, the deceased must either be embalmed (\$995) or refrigerated (\$395) in order to comply with Nevada State law (NRS.451.675)

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are: cardboard containers, composite containers, fiberboard containers, softwood containers, veneer containers, and hardwood containers. We also offer a selection of cremation-oriented caskets that are suitable for cremation. This discounted package includes Basic Services of Funeral Director and Staff; transfer of the deceased from the place of death to the funeral home (within a 30-mile radius); preparation of necessary authorizations, death certificate and permit; and utility vehicle for securing certified death certificate. You may select from a wide variety of urns.

We are unable to mail cremated remains to PO Boxes.
